## **General Conditions**

### **Payment**

Payments of Entry Fees are to be made in **cash** at the show office.

#### **Prizes**

Financial funding in accordance with the 2021 NCHA Official Handbook of Rules and Regulations. Non-financial funding in accordance with the actual information at the 4NCHA website.

## **Objections and protests**

In accordance with the 2021 NCHA Official Handbook of Rules and Regulations.

#### **Covid conditions**

For entering the show we don't require negative test. Please check conditions on borders recommendations for forein participants.

## **Veterinary conditions**

The horses must be vaccinated according to the FEI requirements. The horses must be healthy having NO contagious diseases! The horses must be immune to the influenza. The last vaccination must be completed 7 days before the transport the latest. The horse must have negative coggins blood test for EIA within one year!

#### Veterinarian take-over

The veterinarian take-over will be held on Friday, July  $2^{nd}$ , 2021, between 6p.m. and 8p.m. If otherwise, it must be approved by the doctor veterinarian.

All the horses participating at the show are obliged to pass through the veterinarian takeover. Those horses not having such veterinarian certificate of being able to be shown and







hauled from/to the place of this show and not fulfilling the 2021 legal requirements will NOT be allowed into the area.

Every horse owner or rider is obliged to submit to the show management/doctor veterinarian the relevant documents for hauling an animal in accordance with the veterinarian requirements. All horses must be healthy and have all the appropriate vaccination in accordance with the valid vaccination scheme. All horses must have all the

appropriate examination needed for their transportation and show participation (in accordance with the Czech legal veterinarian requirements). The horse owners and/or the horse riders guarantee that there is no infectious disease at the place the horses are coming from.

## **Entry Form**

The Entry Form must be completed for every pair (rider + horse).

The Entry Form is to be granted only upon the on-time enclosure of the below listed documents (according to the terms & conditions stated below).

By filing the Entry Form, the owner of the horse as well as the rider hereby certify that the horse is in a good health condition and does not suffer from any portable disease, nor has recently the horse been at such environment.

### How to file the Entry Form

The electronically filled Entry form along with all other required documents is valid under the following circumstances:

- the Entry form has been completed correctly and fully
- the responsible person has signed the Entry form
- copy of the relevant Certificate of Registration has been enclosed
- copy of the valid NCHA/4NCHA membership card has been enclosed
- one horse = one Entry Form

Participating at the show is at each one's sole responsibility. The organizer is free of the responsibility of any kind. The horse owners must have a valid insurance against causing damage to third parties. Every horse rider/owner must show to either the show management or the doctor veterinarian the horse's health certificate. This is to be done immediately after coming to the show premises.

I herewith certify that I do agree with all of the above stated requirements. I will obey the show management rules as this is the one in force at this show.

#### Stabling

The stalls will be available from Friday till Sunday at the price of EUR 60, - per one stall.

#### Catering

Food and drinks will be available at the farm restaurant all day long.







## Other requirements

The show participants, the horse owners, the accompanying team members and other persons such as the show visitors, are obliged to obey the rules of the show organizer and other team members as well as they are obliged to obey the general safety rules. The show course is guarded by first the 2021 NCHA Official Handbook of Rules and Regulations available to public at the show office and/or at <a href="https://www.nchacutting.com">www.nchacutting.com</a>, and second by the approved Regulations of animal protection.

There is no contractual relationship being concluded between the show organizer on one side and the show visitors, participants and/or horse owners on the other.

Upon the condition of fulfilling all the appropriate amendments of the Slovakian Civil Code, the area owner bears the responsibility for any potential damage on brings in or laid down things.

Stalling in area is allowed only if approved by the responsible person. The area itself is not guarded. Therefore, places for storing things, such as the saddles, must be explicitly assigned and labeled. The area owner is granted the right to expel cars used for staying overnight. All dogs must be on a guided leash during the show time.

The show participants, the horse owners, the accompanying team members and other persons such as the show visitors, free the show organizer and her team members from any responsibility for any health injuries, stealing, losing and/or damaging things (incl. animals), non-material damages, excluding those cases where such is not allowed in accordance with the generally binding legal law.

The responsibility for damage caused by an animal or thing bears the person responsible for this animal or thing. The responsibility for damage caused by a person bears the one causing such damage or his/her legal representative.

It is recommended that the horse owners take out their own insurance as being the responsible person. The show team members have the right to set rules for the show participants, the horse owners, the accompanying team members and other persons such as the show visitors. The show team members have the right to additionally expel one from the show area in case of his/her violation of the show rules and them placing other persons or animals at risk; the same right is assigned to the judge.

### **NCHA Circuit Show Approved Cutting classes**

**Open -** open to all riders; 1 rider is allowed to show 2 horses.

**Non Pro -** open to all Non Pro/Amateur riders; 1 rider is allowed to show 1 horse.

**Ltd. 5.000 NH -** open to all horses having eligibility earning of \$ 5.000 or less; 1 rider is allowed to show 2 horses.

**Ltd. 25.000 NH -** open to all horses having eligibility earning of \$ 25.000 or less; 1 rider is allowed to show 2 horses.







**Ltd. 50.000 Amt -** open to all Amateur riders having eligibility earnings of \$ 50.000 or less; 1 rider is allowed to show 1 horse.

**Ltd. 15.000 Amt -** open to all Amateur riders having eligibility earnings of \$ 15.000 or less; 1 rider is allowed to show 1 horse.

**Ltd. 2.000 Any Horse/Any Rider -** open to all riders having eligibility earnings of \$ 2.000 or less; any horse may be ridden regardless of ownership; 1 rider is allowed to show 2 horses.





TO HORSES OF ANY AGE. THESE HORSES HAVE TO BE SHOWN ON ROMAL. IT'S OPEN TO NON PRO RIDERS.

**ERCHA OPEN HACKAMORE:** Diese Klasse ist offen für 5 jährige und jüngere Pferde, die noch nicht in Bridle oder Two-rein-Klassen geshowt wurden. OPEN TO HORSES 5 YEARS AND UNDER THAT HAVE NEVER BEEN SHOWN IN A BRIDLE OR TWO-REIN CLASS.

**ERCHA TWO REINS OPEN:** Offen für alle Pferde jeden Alters, die im vergangenen Showjahr noch nicht mit Bridle geshowt wurden. Diese Pferde müssen mit Two Reins geritten werden. Two Reins darf nur 1 Jahr lang geshowt werden. OPEN TO HORSES OF ANY AGE AND UNDER THAT HAVE NEVER BEEN SHOWN IN A BRIDLE CLASS. THESE HORSES ARE ALLOWED TO ENTER THIS CLASS FOR ONE YEAR ONLY. TO BE RITTEN WITH TWO REINS.

**ERCHA NOVICE HORSE OPEN:** Diese Klasse ist offen für Pferde jeden Alters. Pferde müssen mit Snaffle Bit geshowt werden. THIS CLASS IS OPEN TO HORSES OF ANY AGE - SHOWN IN SNAFFLE BIT.

**ERCHA NOVICE HORSE NON PRO:** Diese Klasse ist offen für Pferde jeden Alters. Pferde müssen mit Snaffle Bit geshowt werden. Reiter muss den Status Non Pro haben. THIS CLASS IS OPEN TO HORSES OF ANY AGE - SHOWN IN SNAFFLE BIT. IT'S OPEN TO NON PRO RIDERS.

ERCHA NOVICE RIDERS: Die Pferde werden nur in Reined Work und Boxing geshowt. Die Pferde dürfen zweihändig mit Hackamore oder Snafflebit oder zweihändig mit einem regulärem AQHA Bit geshowt werden. Der Reiter muss nicht der Pferdebesitzer sein. Reiter die in Ihrer Karriere mehr als \$ 1.200,- gewonnen haben dürfen diese Klasse nicht mehr nennen. Es gelten die Regeln der AQHA. HORSES ARE SHOWN IN REINED WORK AND BOXING; HORSES MAY BE SHOWN TWO HANDED IN HACKAMORE OR SNAFFLEBIT OR TWO HANDED WITH REGULAR AQHA BITS. NO LIMITATION ON OWNERSHIP. RIDER THAT HAVE WON \$ 1.200,- IN THEIR CAREER MUST NOT ENTER THIS CLASS. FOLLOWS AQHA RULES.

BEGINNING FENCE (BOX DRIVE BOX): Die Pferde werden nur in Reined Work und Boxing geshowt. Die Pferde dürfen zweihändig mit Hackamore oder Snafflebit (3 – 5 jährig) oder mit TwoReins (wenn TwoRein-Pferd) oder einhändig mit einem regulärem Bridle Bit (Bridle Pferd) geshowt werden. Nur für Non Pro Reiter die nicht auf der Liste der Top Fünf aufscheinen. HORSES ARE SHOWN IN REINED WORK AND BOXING; HORSES MAY BE SHOWN TWO HANDED IN HACKAMORE OR SNAFFLEBIT (3 - 5 years old) OR WITH TWOREINS (if TwoReinHorse) OR ONE HANDED WITH REGULAR BRIDLE BITS (If BridleHorse). ONLY FOR NON-PRO RIDERS NOT APPEARING IN THE TOP FIVE STANDING LIST.
