NCHA Classes 2026

NCHA PREFUTURITY OPEN

Reserved for 3-year-old horses. There is no limit on the number of horses a competitor may show.

NCHA PREFUTURITY NON PRO

Reserved for 3-year-old horses and riders with Non Pro status. There is no limit on the number of horses a competitor may show.

LAE DERBY OPEN

This class is open to riders holding Open status, including professional riders. It is restricted to LAE-eligible horses aged 4 and 5 years, registered in the NCHA LAE Program. Horses must meet all LAE eligibility requirements in accordance with NCHA rules.

A rider may compete with an unlimited number of horses, unless otherwise specified in the show conditions.

LAE DERBY NON-PRO

This class is restricted exclusively to riders holding Non-Professional status under NCHA rules. It is restricted to LAE-eligible horses aged 4 and 5 years. The horse must be owned by the rider or an immediate family member, in accordance with NCHA rules.

A rider may compete with a maximum of 2 horses, unless otherwise specified in the show conditions.

LAE CLASSIC OPEN

This class is open to riders holding Open status. It is restricted to LAE-eligible horses aged 5 and 6 years that meet the requirements of the NCHA LAE Program.

A rider may compete with an unlimited number of horses, unless a limit is specified in the show conditions.

LAE CLASSIC NON-PRO

This class is restricted to riders holding Non-Professional status under NCHA rules. It is restricted to LAE-eligible horses aged 5 and 6 years. The horse must be owned by the rider or a family member, in accordance with NCHA rules.

A rider may compete with a maximum of 2 horses, unless otherwise specified in the show conditions

NCHA OPEN

This class is open to all riders regardless of status (Open, Non-Pro, or Amateur) who are current NCHA members.

There are no limitations on rider or horse earnings, unless otherwise specified in the show propositions.

A rider may show up to 2 horses, unless stated otherwise in the show conditions.



NCHA NON-PRO

This class is restricted to riders holding Non-Professional status under NCHA rules. The rider must not receive any direct or indirect remuneration for training, riding, or assisting in the training of horses.

The horse must be owned by the rider or an immediate family member, in accordance with NCHA rules.

A rider may show 1 horse.

NCHA UNLIMITED AMATEUR

This class is open to riders holding NCHA Amateur status who meet all non-monetary Amateur eligibility requirements.

The class is limited to riders who: are not inducted into the NCHA Hall of Fame, and are over 60 years of age, or are under 60 years of age with lifetime Non-Pro earnings below \$250,000.

A rider may show 1 horse.

NCHA \$75,000 LIMIT AMATEUR

This class is restricted to riders holding NCHA Amateur status whose lifetime earnings, verified at the beginning of the competition year, do not exceed \$75,000.

A rider may show 1 horse.

NCHA \$25,000 NOVICE HORSE

This class is open to Open and Non-Pro riders.

It is restricted to horses whose lifetime earnings at the beginning of the competition year are less than \$25,000, as recorded in the NCHA database.

A rider may show up to 2 horses.

NCHA \$5,000 NOVICE HORSE

This class is open to Open and Non-Pro riders.

It is restricted to horses whose lifetime earnings at the beginning of the competition year do not exceed \$5,000, as recorded by NCHA.

A rider may show up to 2 horses.

NCHA \$25,000 LIMIT AMATEUR

This class is restricted to riders holding NCHA Amateur status whose lifetime earnings do not exceed \$25,000.

A rider may show 1 horse.

NCHA \$4,000 LIMIT RIDER / ANY HORSE

This class is open to riders whose total lifetime earnings in all cutting competitions do not exceed \$4,000.

Any horse may be shown regardless of ownership.

A Non-Pro rider may ride a non-owned horse without losing Non-Pro status.

A rider may show 1 horse.

NCHA YOUTH

This class is restricted to riders who have not reached 18 years of age as of June 1 of the current competition year.

The use of a helmet is mandatory for riders up to 14 years of age and recommended for older youth riders.

A rider may show 1 horse, including a non-owned horse, provided the owner is a current NCHA member.

4NCHA Ranch Cutting

In this class, riders of any status and horses of any age are eligible to compete. The rider must be a current 4NCHA member, and the horse owner must also be a current 4NCHA member.

General Conditions

Payments - Payment of Entry Fees is accepted in cash only and in euros.

Prizes - Financial awards shall be provided in accordance with the 2026 NCHA Official Handbook of Rules and Regulations.

Non-financial awards shall be provided according to the current information published on the 4NCHA website.

Objections and Protests - In accordance with the 2026 NCHA Official Handbook of Rules and Regulations.

Veterinary Conditions - Horses must be vaccinated in accordance with NCHA requirements.

All horses must be healthy and free from any contagious diseases.

Horses must be immune to equine influenza.

The last vaccination must be administered no later than seven (7) days prior to transport.

All horses must have a recorded negative test result for Equine Infectious Anemia (EIA), not older than six (12) months, duly entered in the horse passport.

Veterinary Inspection (Veterinarian Take-Over) - The veterinary inspection shall take place on Friday upon arrival at the show grounds.

Any alternative time must be approved by the attending veterinarian.

All horses participating in the show are required to undergo the veterinary inspection.

Horses that do not have a veterinary certificate confirming their fitness to compete and to be transported, or that do not comply with the legal veterinary requirements valid for the year 2026, will not be admitted to the show grounds.



Each horse owner or rider is required to present all relevant documents necessary for the transport of the animal to the show organizer or veterinarian, in accordance with veterinary regulations.

All horses must be healthy and properly vaccinated according to the valid vaccination schedule.

All horses must have all mandatory examinations required for transport and participation in the show, in accordance with the applicable veterinary regulations of the Slovak Republic.

Horse owners and/or riders guarantee that no infectious disease is present at the place of origin of the horses.

Entry Form - The Entry Form must be completed for each horse-and-rider combination via www.eurorodeo.eu.

The Entry Form shall be considered valid only upon timely submission of all documents listed below, in accordance with the conditions stated herein.

The rider is required to submit the Entry Form no later than fourteen (14) days prior to the show date.

Any late entry will be subject to a penalty.

If a rider withdraws from a class during the show, the entry fee shall not be refunded.

By submitting the Entry Form, both the horse owner and the rider confirm that the horse is in good health, does not suffer from any transmissible disease, and has not recently been exposed to an environment with infectious disease occurrence.

The owner of each horse participating in an NCHA Show must:

1. be a current member of NCHA / 4NCHA, and
2. submit a horse registration certificate listing the owner accordingly.

If the ownership transfer has not been completed prior to the show, the owner is obliged to complete the ownership transfer with the breed registry as soon as possible.

Failure to do so may result in penalties imposed by NCHA.

Participation in the show is entirely at the participant's own risk.

The organizer assumes no liability of any kind.

Horse owners must hold valid third-party liability insurance.

Each horse owner or rider is required to present the horse's health certificate immediately upon arrival at the show grounds to the show organizer or veterinarian.

By submitting the Entry Form, I hereby confirm my agreement with all of the above conditions and undertake to comply with the rules of the show organizer, which are in force during this show.

Stabling - Stalls are available from Friday to Sunday at a price of EUR 110 per stall.

Catering - Food and beverages will be available all day at the buffet.

Other Conditions - Show participants, horse owners, accompanying team members, and visitors are required to follow the instructions of the show organizer, organizing staff, and general safety regulations.

The show is governed by: the 2026 NCHA Official Handbook of Rules and Regulations, available at the show office and at www.nchacutting.com, and the approved animal welfare regulations.

No contractual relationship is established between the show organizer and visitors, participants, and/or horse owners.

Subject to compliance with the Slovak Civil Code, the venue owner bears responsibility for damage to items brought into or stored on the premises.

Stabling within the venue is permitted only with the approval of the responsible person.

The venue is not guarded, therefore storage areas for equipment (e.g. saddles) must be explicitly designated and marked.

The venue owner reserves the right to remove vehicles used for overnight stays.

All dogs must be kept on a leash at all times during the show.

Participants, horse owners, accompanying teams, and visitors release the organizer and its team from any liability for:

injuries, theft, loss or damage of property (including animals), non-material damages, except in cases where liability cannot be excluded under applicable law.

Liability for damage caused by an animal or object rests with the person responsible for that animal or object.

Liability for damage caused by a person rests with the individual who caused the damage or their legal representative.

Horse owners are strongly recommended to obtain their own insurance.

Members of the organizing team have the right to: establish rules for participants and visitors, expel any person from the show grounds who violates show rules or endangers people or animals.

This right also applies to the judge.
